



#### **A Father-Son Big Year of Birding and Beyond** *By Sneed B. Collard III*

Join Bitterroot Audubon as acclaimed author Sneed B. Collard III recounts the entertaining adventures behind his humorous, award-winning memoir *Warblers and Woodpeckers: A Father-Son Big Year of Birding* (Mountaineers, 2018) and other bird books and articles. Along the way, participants will travel to some of America's best birding hotspots as well as to South America, the Galápagos, and the Middle East. He'll also recall his sons and his "accidental Big Years" of 2022 featuring Pinky, America's most famous flamingo.



Sneed has written more than ninety books for young people including *Beaks! Fire Birds—Valuing Natural Wildfires and Burned Forests*; *Woodpeckers—Drilling Holes and Bagging Bugs*; *Waiting for a Warbler*; and his newest picture book, *Border Crossings*. Sneed is a popular, awardwinning speaker and has spoken at numerous birding festivals and events. I love birding in that part of the country! And then, towards the end of the year, my yard saw several visits from Sharp-shinned Hawks and one visit from a Northern Goshawk. I loved watching them. Add the Stevensville Christmas Bird Count, which included great views of a Ferruginous Hawk, on the last day of the year, and I felt a little better about 2022. For now, those birding adventures will be close to home, and even at home, through my windows. In addition to raptors, I've been watching Dark-eyed Juncos clean up seed on the ground. I only have Oregon and Slate-colored Juncos visit my yard, and I have seen Yellow-eyed Juncos in SE Arizona. But I learned about many other regional variations in Audubon's recent article "Dark-eyed Juncos, Backyard Gems, Come in a Dazzling Array of Colors." My yard is a little bleak at the moment, so I am looking out the window, imagining what I'll see when I have improved the habitat and tempted more pollinators and birds to my yard

I urge you to read that article and sign up for Montana Audubon's Action Alerts. Laws passed in the last legislative session were tough on wildlife, especially wolves. In this session, legislators could again target (sorry for the pun) wildlife and the habitat on which it depends.

#### Montana's 2023 Legislative Session By Micki Long

As I'm sure you're all aware, Montana's 68<sup>th</sup> Legislature began on January 2, 2023. The previous Legislature was a tough one for wildlife, most notably for wolves. Many conservation-minded groups are steeling themselves against what this session could bring. Among the most serious concerns is that some legislators are focusing on Montana's State Constitution and its inclusion of a "clean and healthful environment" among the inalienable rights listed in Article II, Section 3. Montana Audubon, Montana Wild, and the Montana Conservation Voters have provided information and tools to help you keep abreast of bills introduced in this legislation session.

First, Montana Audubon offers several ways to stay informed and take action. You can: 1) Subscribe to Action Alerts, 2) See what bills Montana Audubon is tracking, 3) Learn how to testify remotely, 4) See what committees Montana Audubon is watching, 5) and get contact info for your legislators and for staff at Montana Audubon who focus on the legislature.

The Montana Conservation Voters offers a petition designed to protect the Constitution's "clean and healthful" promise; even if you don't want to sign the petition, you can learn much about the subject from the text of the petition. Keep in mind that it is usually more effective to contact your legislators in your own words, through phone call or emails. But if you prefer not to do so, consider signing this petition:
